**Joint HR and Finance Circular 011/2020: Clarification on recruitment derogation – COVID 19 Response**

A National HR memo on the *Policy on Redeployment of Staff during COVID-19 Infection* has already issued (6<sup>th</sup> March 2020). In the context of our multipronged efforts to enable the health service's response to COVID 19, and in consultation with the HSE Chief Operations Officer, we wish to provide the following clarifications to ensure that there are no barriers to the necessary recruitment of the health workforce that is required to support our services during the COVID-19 response.

The following is applicable with immediate effect;

- I. The affordability measures outlined in the Memo of 20<sup>th</sup> June 2019 are paused until further notice.
- II. Consequently, this reinstates National Director authority to delegate the decisions and accountability for same, with the following exceptions:
  - a. Consultant posts will continue to require submission nationally;
  - b. New Senior Management and Administration posts continue to require submission nationally in line with the National HR memo of 28<sup>th</sup> February 2020;
- III. As deemed appropriate, each National Director, in delegating these functions, is required to formally set out individual arrangements for their areas of responsibility, to provide for the necessary governance and oversight of same, including those specifically in respect of the drawdown of the COVID-19 funding. These arrangements should issue without undue delay to provide clarity of arrangements.
- IV. These arrangements are required to support the minimum data requirements for the overall management of our response to COVID-19 which will include weekly and monthly updates. This will include recruitment activity by each National Director for their areas of responsibility. Required data fields will include at a minimum; WTE, Grade, Location and 'in-post' recruitment date.
